The Board is pleased to announce that the English name of the Company has been changed from “China Bio Cassava Holdings Limited” to “Cloud Investment Holdings Limited” and the Chinese name of the Company has been changed from “中國生物資源控股有限公司” to “雲信投資控股有限公司”, both with effect from 27 September 2017.

CHANGE OF STOCK SHORT NAMES

The stock short names of the Company for trading in the Shares on the Stock Exchange will be changed from “CH BIO CASSAVA” to “CLOUD INV HOLD” in English and from “中國生物資源” to “雲信投資控股” in Chinese with effect from 9:00 a.m., 14 November 2017.

CHANGE OF COMPANY NAME

The Board is pleased to announce that, subsequent to the passing of a special resolution in relation to the proposed Change of Company by the Shareholders at the EGM held on 22 September 2017, the Registry of Companies in the Cayman Islands has approved the registration of the new name of the Company and issued the Certificate of Incorporation on Change of Name on 27 September 2017. The conditions for the Change of Company Name have therefore been satisfied and the English name of the Company has been changed from “China Bio Cassava Holdings Limited” to “Cloud Investment Holdings Limited” and the Chinese name of the Company has been changed from “中國生物資源控股有限公司” to “雲信投資控股有限公司”, both with effect from 27 September 2017. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 1 November 2017 confirming the registration of the new names of the Company in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

CHANGE OF STOCK SHORT NAMES

Following the change of the Company name becoming effective, the stock short names of the Company for trading in the Shares on the Stock Exchange will be changed from “CH BIO CASSAVA” to “CLOUD INV HOLD” in English and from “中國生物資源” to “雲信投資控股” in Chinese with effect from 9:00 a.m., 14 November 2017.
